



**KANO STATE SUPPLEMENTARY APPROPRIATION LAW,
2023 (1445 A.H.)**

A LAW TO PROVIDE FOR THE KANO STATE SUPPLEMENTARY APPROPRIATION LAW, 2023 (1445 A.H) TO THE TUNE OF N58,191,535,018.12 WHICH BRINGS THE TOTAL BUDGET SIZE OF 2023 (1445 A.H) TO STAND AT N326,389,266,018.12 AND FOR OTHER MATTERS CONNECTED THEREWITH.

WHEREAS the Kano State Appropriation Law, 2023 (1444 A.H) was assented to, by the Kano State Governor in compliance with the provision of section 121(4)(b) of the Constitution of the Federal Republic of Nigeria, 1999 (as amended).

AND WHEREAS the implementation of the amounts stated in the schedule to the said Appropriation Law requires some necessary amendment.

AND WHEREAS a need has arisen for expenditure for a purpose for which no amount has been appropriated by the said law.

AND WHEREAS by the letter dated 21st September, 2023 signed by the Kano State Governor and addressed to the Kano State House of Assembly requesting for such Supplementary/Amendment to the said schedule.

NOW THEREFORE IT IS HEREBY ENACTED by the Kano State House of Assembly as follows: -

Citation and Commencement 1. This Law may be cited as the Kano State Supplementary Appropriation Law, 2023 (1445 A.H) and shall come into operation on^{13TH}..... day of.....OCTOBER.....2023 (1445 AH).

Issues and Appropriation of N58,191,535,018.12 2 (1) The Accountant General of Kano State may when authorized to do so by warrant sign as authorized by section 120 (2) of the Constitution of the Federal Republic of Nigeria 1999 (as amended) issue from the Consolidated Revenue Fund of the State during the year ending on 31st December, 2023 the sum specified by the warrants not exceeding in the aggregate of **N58,191,535,018.12 (Fifty-Eight Billion, One Hundred and Ninety-One Million, Five-Hundred and Thirty-Five Thousand, Eighteen Naira and Twelve Kobo)** only being the total amount set forth opposite Code 010000000000 and 055100100100 in the schedule to this Law.
(2) The said sum shall be appropriated for the purpose and in the manner expressed in the Schedule to this Law.

Lapsing unissued amount of 3. The monies granted by this Law are provided for the services in respect of which monies will become payable within the year ending 31st December, 2023 and any lapse shall not be available for making any payment in any subsequent month.


