1 Summary of Performance

1.A Introduction

This Budget Performance Report for Kano State is prepared quarterly and issued within 4 weeks from the end of each quarter.

The report includes the original approved budget appropriation for the year 2023 against each organizational unit for each of the core economic classification of expenditures (Personnel, Overheads, Capital, and Others); the actual expenditures for the quarter three (Quarter 3), attributed to each organizational unit, as well as the cumulative expenditures for year to date, and balances against each of the revenue and expenditure appropriations.

This Quarter report is assessed against the 2023 Original budget. But is pertinent to note that, in the course of implementation of the 2023 Budget certain Budget provisions were overperformed in the area of Revenue and Expenditure. Therefore, all the affected Budget Provisions will be formalised which will be forwarded to the State House of Assembly for the passage.

This Budget Performance Report is produced by the Ministry of Planning and Budget in collaboration with Account General Office of the Ministry of Finance and published on the Kano State website.

1.B Revenue Performance

The Revenue comprises of the:

- i. Recurrent Revenue
- ii. Capital Receipts

In the 2023 Approved Budget, the Total Revenue was projected to be **₦ 268,197,731,000.00**. The actual revenue for the 2023 (Q3) is **₦55,788,909,628.71**, while January to June is recorded as **₦ 167,121,688,147.42** which gives a Revenue performance of **62.3%** from January-September 2023.

The Government Share of FAAC and the Independent Revenue forms part of the Recurrent Revenue.

Table 1 shows the breakdown of the Recurrent revenue performance.

The 2023 Recurrent Revenue Budget was projected to be **₦194,989,514,986.58**, with an actual of **₦ 55,788,909,628.71** for the third quarter while Cumulative Performance from January to September **₦ 132,809,843,147.42** resulting to a Performance of 68.1% out of which the Government share of FAAC is **₦ 154,662,468,132.11** with an actual of **₦50,530,549,591.64** for the quarter under review while cumulative is reading **₦103,219,418,637.10** resulting to a performance of 66.7 % while the Independent Revenue was projected to be **₦40,327,046,854.47** with an actual of **₦5,258,360,037.07** for the quarter under review while cumulative performance is **₦29,590,424,510.32** resulting to a Performance of 73.4%.

Equally, it is very important that, Some Revenue Items were over performed during the course of Budget Implementation in the Quarter under review. This was as a result of IGR reforms introduced to boost the Collection as well as some backlog that was received by the State. All the affected Items will be formalised during Budget Supplementary/Amendment,

The Capital Receipts was projected to be **₦47,200,001,107.50** with an actual of **₦ 2,142,280,000.00** as draw dawn data as the third quarter and this gives a variance of **₦ 45,057,721,107.50** resulting to a Performance of 4.5%. However, it is equally important to note that efforts are on-going to create effective strategy amongst MDAs to ensure timely availability of Capital Receipts data in the subsequent Reports.

1.C Recurrent Expenditure Performance

The Recurrent Expenditure is divided into:

- i. The Personnel Cost
- ii. Other Recurrent Expenditure

The 2023 Recurrent Expenditure Budget was projected to be ₦109,969,480,943.78 with an actual of ₦ **24,239,130,026.79** for the third quarter while cumulative performance is **N73,293,125,261.29 resulting** to a Performance of 66.6% The Personnel cost was projected to be ₦ 72,980,158,656.60 with an actual of ₦18,245,039,664.15 for the quarter. The Other Recurrent Expenditure was projected to be ₦ 36,989,322,287.17 with an actual of ₦ 5,994,090,362.64 while cumulative is N23,783,487,317.11 resulting to a Performance of 64.3%A number of MDAs have already overspent their budget for 2023 and resulted to initiate Budget formalisation where all these related issues will be address. The overperformance of these items were as a result of Government priorities introduced to improve Service Delivery in the state. The affected Items will also be formalised during Budget Supplementary/Amendment.

1.D Capital Expenditure Performance

The Capital Expenditure was projected to be ₦158,228,250,056.23 with an actual of ₦1,068,467,832.28 for the third quarter while cumulative is N12,272,395,291.83 resulting to a Performance of 7.8%

1.E Conclusions

In Conclusion, the total final budget size for 2023 was projected to be ₦ 268,197,731,000.00 giving an actual revenue performance of ₦**167,121,688,147.42** for the year representing **62.3%** achievement with corresponding expenditure of ₦ **85,565,520,553.12** which represent 31.9%performance. The state is also working hard to harness more of its capital receipt projections so as to improve the performance in subsequent quarters.
